A regular meeting of the Firefighters' Pension Investment Fund of Illinois Elections Panel was held on Thursday, August 12, 2021 at 1:00 p.m. at the FPIF Headquarters located at 1919 S. Highland Avenue – Building A, Suite 237, Lombard, Illinois 60148 and via videoconference in accordance with Public Act 101-0640, pursuant to notice.

III. Approval of the July 29, 2021 Meeting Minutes

IV. <u>Determination of the Final 2021 FPIF Trustee Special Election Slate of</u> <u>Candidates</u>

Panel Clerk Steve Zahn informed the Board the nominating petition challenge period has concluded, and no petition challenges were received by the FPIF Elections Panel. Mr. Zahn reviewed the slate of candidates for the panel resulting in Mayor Tom Dailly being the only candidate for the Executive Trustee position with a January 2, 2025 term end date and both Mr. Christopher Minick and Treasurer John Perry being candidates for the Executive Trustee position with a January 3, 2023 term end date. Mr. Zahn informed the Panel that Mr. Minick has changed employers from the Village of St. Charles to the City of Aurora and Mayer Brown has confirmed that no break in service has occurred allowing Mr. Minick to maintain his eligibility as an Executive Trustee candidate.

A motion was made by Panel Member Shetsky and seconded by Panel Member Hayes to determine Mr. Tom Dailly as a candidate for the term ending January 2, 2025 and both Mr. Minick and Mr. Perry as candidates for the term ending January 3, 2023. Motion carried by roll call vote.
