## I. Call to Order

Chairman Hunt called the meeting to order at 2:00 p.m.

## II. Taking of the Roll

Robina Amato of Lauterbach & Amen, LLP took the roll. Chairman Hunt, Trustee Kink, and Trustee Rowitz were present; there were no absences.

#### **III.** Approval of Meeting Minutes

The Committee reviewed the April 15, 2020 Audit Committee meeting minutes. A motion was made by Trustee Rowitz and seconded by Trustee Kink to approve the April 15, 2020 meeting minutes as written. Motion carried unanimously by voice vote.

## IV. Financial Report

Director Atwood introduced A.J. Weber from Lauterbach & Amen, LLP who reviewed the previously approved June 30, 2020 budget with the Committee and presented the Firefighters' Pension Investment Fund Expense Report as of April 30, 2020.

Director Atwood reviewed projections for legal fees for the remaining June 30, 2020 budget and over the next 18 months while addressing Trustee Rowitz's inquiries regarding associates and partner billing rates.

A motion was made by Trustee Kink and seconded by Trustee Rowitz to accept the April 30, 2020 Financial Report. Motion carried unanimously by voice vote.

#### V. FY 2021 Budget

Director Atwood presented the preliminary June 30, 2021 budget prepared by L&A and reviewed projected monthly costs associated with accounting and client services, the pending office lease and D&O insurance.

Director Atwood explained the purpose for custodian and audit fees to build the infrastructure in anticipation of transferring assets from the local Article 4 pension funds.
