

MINUTES OF A REGULAR MEETING OF THE FIREFIGHTERS' PENSION INVESTMENT FUND ELECTIONS COMMITTEE FEBRUARY 11, 2022

A regular meeting of the Firefighters' Pension Investment Fund of Illinois Elections Committee was held on Friday, February 11, 2022 at 10:00 a.m. at the FPIF Headquarters located at 1919 S. Highland Avenue – Building A, Suite 237, Lombard, Illinois 60148 and via videoconference in accordance with Public Act 101-0640, pursuant to notice.

I. Call to Order

Chairman Schick called the meeting to order at 10:00 a.m.

III. Approval of May 14, 2021 Meeting Minutes

IV. Consideration for Approval for 2nd Public Notice of FPIF Trustee Election Rules

Mr. Zahn presented the draft FPIF Trustee Election Rules to the Committee along with a summary of revisions to the rules and a sample election timeline. Mr. Zahn informed the Board these rules will be the permanent rules of the FPIF Board of Trustees and also govern Special Elections. The Committee reviewed a public comment submitted by Mayor Julie Moore Wolfe from the City of Decatur, Illinois. Mayor Wolfe's comments were in regard to the 100-day period for candidates to circulate nominating petitions; Mayor Wolfe suggested a 5-week period be sufficient for executive Trustee candidates who are required to obtain 20 valid signatures. Vice Chairman Cole suggested that requested election materials be sent to eligible voters in a form other than the United States Postal Service at the requestor's expense to insure timely delivery and participation in any election.
