

MINUTES OF A REGULAR MEETING OF THE FIREFIGHTERS' PENSION INVESTMENT FUND LEGISLATIVE COMMITTEE FEBRUARY 9, 2023

A regular meeting of the Firefighters' Pension Investment Fund of Illinois Legislative Committee was held on Thursday, February 9, 2023 at 8:00 a.m. at the FPIF Headquarters located at 1919 S. Highland Avenue – Building A, Suite 237, Lombard, Illinois 60148 and via videoconference in accordance with Public Act 101-0640, pursuant to notice.

I. Call to Order

Vice Chair Sullivan called the meeting to order at 8:00 a.m.

III. Election of Chairperson

The Committee discussed electing Vice Chair Sullivan as the Chairperson for the Legislative Committee. A motion was made by Trustee Cole and seconded by Trustee Krieger to elect Trustee Sullivan as the Chairperson of the FPIF Legislative Committee. Motion carried by roll call vote.

V. Legislative Update

Mr. Zahn reviewed the Legislative Report summarizing HB 1248 FPIF Board of Trustees – Fire Protection District Member and SB 238 Veteran Owned Businesses. Trustee Cole noted this Committee is monitoring both bills and no action is currently being taken.

VI. Consideration and Approval – FPIF Legislation

Mr. Zahn presented a memorandum to the Committee summarizing proposed FPIF legislation including amendments to the FPIF Oath of Office, Trustee Travel Expenses, Participant and Beneficiary Ballots, Trustee Vacancies, Publishing of FPIF Rules and Custodian – Corporate Surety Bond. A full, red-lined version of the proposed legislation was provided to the Committee for review. The Committee discussed amending the current proposed legislation regarding Trustee Vacancies to read "A trustee appointed to fill the vacancy of an elected trustee shall serve until a successor is elected."

Trustee Skilondz inquired as to whom is responsible for appointing a trustee to fill a vacancy. Mr. Zahn reviewed the appointment process and Trustee Cole confirmed that the FPIF Board of Trustees considers the final appointment with deference being given to the firefighter trustees to recommend a candidate filling a firefighter trustee vacancy and to executive trustees to recommend a candidate to fill an executive trustee vacancy.

A motion was made by Trustee Cole and seconded by Trustee Bramwell to recommend to the Board of Trustee for approval the FPIF legislation as amended. Motion carried by roll call vote.
